Addendum One to the Request for Proposals CMD #20-02 shall cause the following revisions. **Double strikethroughs signify deletions and underline font signify additions.**

1. RFP Section 3.0 PROPOSER'S MINIMUM QUALIFICATIONS, has been revised to read as follows:

3.0 PROPOSER'S MINIMUM QUALIFICATIONS

Interested and qualified Proposers that can demonstrate their ability and qualifications to successfully provide the required services outlined in Appendix A, Statement of Work of this RFP are invited to submit proposal(s), provided they meet the following mandatory requirements by the proposal submission date:

Minimum Mandatory Requirements

3.1 Proposer must have five (5) years' experience within the last seven (7) years providing both armed and unarmed security guard services equivalent or substantially similar to the services identified in Appendix A, Statement of Work, of this RFP. ~~with a minimum aggregate total of 250 guards, at all times, located in one or multiple locations.~~ Proposer must provide references to verify this ~~requirement~~ experience. The experience must be documented in Proposal, Subsection B.1.

3.2 Proposer applying for one Sector must have, within the last five years, a minimum aggregate total of 125 guards available at all times to provide security guards services. Proposer must provide references to verify this requirement. The experience must be documented in Proposal, Subsection B.1.

OR

Proposers applying for two Sectors must have, within the last five years, a minimum aggregate total of 250 guards available at all times to provide security guard services. Proposer must provide references to verify this requirement. The experience must be documented in Proposal, Subsection B.1.

~~3.2~~3.3 Proposer must provide at least one (1) assigned full-time Contractor Project Manager, with a minimum of three (3) years' experience within the last five (5) years providing security management services equivalent or substantially similar to those required in this RFP, including management and coordination of services and acting as a "central point of contact" for security services. Proposer shall submit resume and include references that verify this experience for the

proposed Contractor Project Manager. The experience must be documented in Proposal, Subsection B.1.

- ~~3.3~~3.4 Proposer must have at least one (1) assigned full-time Contractor Contract Manager, with a minimum of three (3) years' experience within the last five (5) years providing contract management services equivalent or substantially similar to those required in this RFP. Proposer shall submit resume and include references that verify this experience for the proposed Contractor Contract Manager. The experience must be documented in Proposal, Subsection B.1.
- ~~3.4~~3.5 Proposer must have a valid and active California-issued private patrol operator license to perform the requested services.
- ~~3.5~~3.6 Proposer must attend the mandatory Proposer's Conference, as specified in this RFP, Subsection 7.7, Proposers' Conference.
- ~~3.6~~3.7 If Proposer's compliance with a County contract has been reviewed by the Department of the Auditor-Controller within the last 10 years, Proposer must not have unresolved questioned costs identified by the Auditor-Controller, in an amount over \$100,000.00, that are confirmed to be disallowed costs by the contracting County department, and remain unpaid for six months or more from the date of disallowance, unless such disallowed costs are the subject of current good faith negotiations to resolve the disallowed costs, in the opinion of the County.
- ~~3.7~~3.8 The use of subcontractors is prohibited for providing armed and unarmed security guard services. Please disregard all references to subcontractors in the RFP.

Minimum Mandatory Requirements 3.1 through ~~3.7~~ 3.8 above must be addressed and submitted with the submitted Proposal. Failure to meet these Minimum Mandatory Requirements will result in a rejection of a proposal as explained in RFP, Section 7.0, Proposal Submission Requirements, hereunder.
