# 5.0 DIRECTOR'S REPORT

Jackie Contreras, Ph.D., Director

Dr. Contreras provided an update on the following topics:

The Board Made the following Proclamations for the month of February 2024: African American History Month highlighting and acknowledging notable African Americans who have contributed to their respective professions. Teen Dating Violence Awareness and Prevention Month encouraging all County employees and residents to be aware of warning signs of teen dating violence, and to connect youth survivors with trusted adults and providers who provide dating/domestic/intimate partner violence supportive services. National Children's Dental Health Month throughout LA County and urge the Department of Public Health to do outreach to residents, schools, and community organizations to join in this observance. In addition, the Board has also proclaimed: February 2, National Wear Red Day spreading awareness about women's heart health. Spay/Neuter Awareness Month promoting no-cost and low-cost spay/neuter services on County and Department of Animal Care and Control websites and social media accounts, including other resources and services provided by community rescues and organizations, for the month of February.

**Follow up Item:** Vice Chair ElHessen asked does the Department have anything in place that would address emergency preparedness for IHSS caregivers and Social Workers? She has worked with the cities, LA County Fire Chief and Sheriff regarding emergency preparedness / CERT Training for our most vulnerable population. She asked if caregivers and social workers can take this training. Her concern is (based on what emergency responders told her) that when there is a crisis or emergency situation, they cannot go to every single call.

If there were competing emergencies between a school and nursing care facility (both are of equal distance), the emergency response team would go to the school first. This made me think from a broader perspective how important the CERT training is.
