# How to Apply for General Relief by Mail

**General Relief (GR)** is a program funded by Los Angeles County for persons in need who are not eligible for other federal or State assistance programs, such as CalWORKs, Supplemental Security Income (SSI), Disability Insurance Benefits (DIB), etc. GR includes a monthly cash grant of \$221 for one person, and \$375 for a couple.

#### **GR Eligibility Requirements**

In order to be eligible to receive GR you must meet all of the following requirements:

- You must be a resident of Los Angeles County.
- You must provide a photo ID, in person, at the time of GR application to verify your identity unless you have previously provided a copy.
- Applicants must declare their citizenship status and provide verification or have verification on file.
- Your monthly net income (after deductions) must be lower than the maximum GR grant of \$221 for one person.
- Your personal property must have a combined value of \$2,000 or less per household.
- You may only own one motor vehicle and it must be valued at \$4,500 or less. If you are homeless and use your motor vehicle as a residence, you may only own one motor vehicle and it must be valued at \$11,500 or less.
- Cash on hand or in a bank account valued at \$100 or less at application, or \$1,500 or less after approval.
- Real Property (home) has an assessed value of \$34,000 or less and an applicant must sign a lien, allowing the County to recover GR payments received under certain circumstances.

## Who is Not Eligible for GR?

An individual is ineligible to GR if he or she:

- Does not meet the criteria above.
- Is in violation of probation or parole.
- Is fleeing to avoid prosecution or custody/confinement after a felony conviction.

# How to Apply for General Relief by Mail

## STEP 2 Please submit verification of the following, if they apply to you:

- If you work or receive <u>any</u> income (for example: wages/tips, UIB, DIB, SSI, VA benefits, Workers Comp, pension pay, settlement payments, etc.)
- If you own any Bank Accounts, IRA's, Trust Funds etc.
- If you own a car, motor home, home, any other property, etc.
- If you pay rent/mortgage/utilities

Click on the <u>Most Commonly Requested Documents link</u> to get a list of required verification documents/proof needed to apply for GR.

STEP 3 Mail your GR application along with the rest of your GR forms and any other documents to:

- A worker will call you to schedule an appointment at a GR office within five business days of receipt of your application.
- During your appointment the worker will:
- ✓ Go over your GR application and forms you submitted to determine if additional information is needed.
- If your application is complete, determine if you are eligible for GR.
- ✓ Inform you if you are eligible to receive emergency housing, if you need it.
- ✓ Issue an EBT card, if needed.
